



2024 REGULATIONS

RIGHT TO FISH

- Access to the lake is by reservation only, by contacting us in advance and returning the reservation voucher which will be sent to you after an initial telephone or email contact.
- The 50% deposit is mandatory to book your stay and will not be refunded under any circumstances
- In case of cancellation + 2 months before the scheduled date, the stay may be postponed to a later session over 12 months,
- If the cancellation occurs less than 2 months before the arrival date, it will be lost if you do not come or it may be transferred to a third party.
- No refund, postponement or credit note in the event of early departure by the fisherman and/or accompanying person will be made for any reason
- A deposit of €200 will be requested on arrival, it will not be cashed and will be returned on your departure after checking the cleanliness of the station and returning the loaned equipment in good condition (mat, landing net, weighing bag)
- Dogs are tolerated on the site (1 dog per station) and under the full responsibility of the person who has booked. Deposit 50€ + shovel mandatory to be presented on arrival
- The entrance gate to the gravel pit is locked by a code padlock. We will send you the code upon arrival.
- Closing the gate is mandatory after each opening

DEPARTS / ARRIVEES

- **The reception is only open for arrivals and departures according to reservations**
- Departures are at 9 a.m.
- Arrivals at the stations are from 10 a.m. to 12 P.M. FOR ALL FISHERMEN / ACCOMPANYING PERSONS
- No departure or arrival will be allowed outside the time slots, please make your own arrangements.
- Installation on the workstations before going to the reception is forbidden
- No change of position can take place without our permission.

ACCOMPANYING PERSONS

- Limit of 2 adults per station (non-fisher),
- "Companion package" to be subscribed to when you book
- Free for children under 18 years old.

VISITS

- Visitors are tolerated on the site, within reason (close family or friend)
- **MAX 4 VISITORS AT THE SAME TIME** per station, only with the authorisation of the managers and after signing a certificate for the wearing of the life jacket for stations 1 and 2.
- They will have to park their vehicles **OUTSIDE** the site and will have to reach the station on foot
- They will have to leave the water at 6 p.m. maximum. Any visitor present without authorization will be forced to leave the site without delay and will result in the payment of the deposit

VEHICLES AND TRAFFIC ON THE SITE

- Vehicle traffic around the lake is allowed on arrival and departure at the berths.
- The vehicles must then be parked in the designated spaces
- The maximum speed allowed around the body of water is 20km/h.

BAIT BOATS AND BOATS

- Bait boats are authorized in accordance with the station limits shown on the plan and marked on the lake.
- The boat is only made available from berth 1 and 2 to reach the bank, in no case will they be used to drop lines, bait, fight or transport equipment.
- The use of the boat in fishing action is **ONLY** allowed in November.
- The life jacket is provided on your arrival and is **MANDATORY** when using the boats, any fisherman releases the company SAS AD FISHING - carpe experience, from any responsibility in the event of an accident of any kind whatsoever and assures that he will renounce any action against him

FISHING

- Swimming prohibited
- Only green or camouflage bivvys, tent umbrellas or umbrellas are allowed.
- Carp fishing is done with 3 rods per angler – 4th optional
- One single hook per line, micro-barb hook only.
- Authorized hook sizes: from 2 to 6.
- Only one leader per rod!
- Nylon main line of 0.30mm (30 hundredths) minimum, braid allowed in main line.
- **Nylon leader MANDATORY between 40/100th and 50/100th.**
- The rigs must allow the lead to be easily detached from the rig in the event of breakage, and the fish to be released in the event of breakage. The strength of the leader must be lower than that of the main line.
- **Blocked mounting prohibited**
- Lead clip must not be blocked on the swivel
- Anti-tangle sheath forbidden
- Magic-twg lead clip forbidden (see photo)
- Leadcore, leader in fluro or tungsten forbidden as well as all the sheaths serve as anti-tangle (see photo)
- It is forbidden to use your landing nets, weighing bags and landing mats, these accessories being provided on arrival for health reasons.
- The handling of the fish must be done with the greatest care: water the fish abundantly, kneeling photo session (it is forbidden to stand with the fish in your hands), release the fish immediately after the photo session and as soon as possible.
- **STORAGE BAGS PROHIBITED** (immediate exclusion without refund).
- **ALL SEEDS ARE FORBIDDEN** except sweet corn, toasted seeds and those sold by Carpe experience. (**no seeds from outside the estate will be accepted**).
- Boilie cannons are prohibited.
- Predator fishing is prohibited.
- A shot rod is tolerated by angler, but only in **NO KILL** (no Feeder rod or English rod)
- Prohibited hampers
- Each fisherman must respect the distances and the fishing area associated with the position he occupies.
- -Anglers must be present at their post when the lines are in the water.
- If you have to be absent (even on the next station) **please raise your rods.**
- We send one rig per session, randomly, to all the fishermen, in order to

- monitor compliance with the regulations.

GENERAL

- Ground fires are prohibited. Above-ground barbecue tolerated, The ashes must be emptied in a garbage bag, and taken away at the end of the session. A bucket of water filled, ready to extinguish any overflow, should be nearby when barbecuing.
- Stations must be clean at the time of your departure, and all garbage must have been picked up and brought back at the end of the session.
- **IT IS FORBIDDEN TO THROW YOUR CIGARETTE BUTTS ON LAND OR IN THE WATER!**
- Hunting and swimming are strictly forbidden on the site.
- Toilets and sanitary facilities are available on the site, please respect them and keep these spaces clean after your visit.
- It is forbidden to cut down trees, shrubs or plants, to damage boats, toilets or other installations within the enclosure of the lake.
- There are sheep present on the site. It is forbidden to feed and frighten them.
- Please respect the surrounding wildlife.
- The lighting at night and the noise level of the detectors must be reasonable, so as not to disturb the tranquility of the site and the smooth running of the session of the other fishermen.
- -Proper attire required. Drug use, drunkenness, rowdiness or a disrespectful attitude towards other fishermen or managers will result in immediate and permanent exclusion without refund of the sums paid, and may eventually lead to legal proceedings.
- All our fish are listed so that we can keep track. Any attempt to steal, maim or poach will result in prosecution.
- For your safety, the site is under 24-hour video surveillance and increased surveillance is carried out on the gravel pit.
- Generators are FORBIDDEN

When you book carpe experience, you are booking a stay at a fishing center, not a leisure center. You therefore agree to respect the rules, the site and the other fishermen.

ANIMALS

-Dogs are tolerated on the site (1 dog per station) and under the full responsibility of the person who booked.

- deposit 50€ + shovel mandatory to be presented on arrival

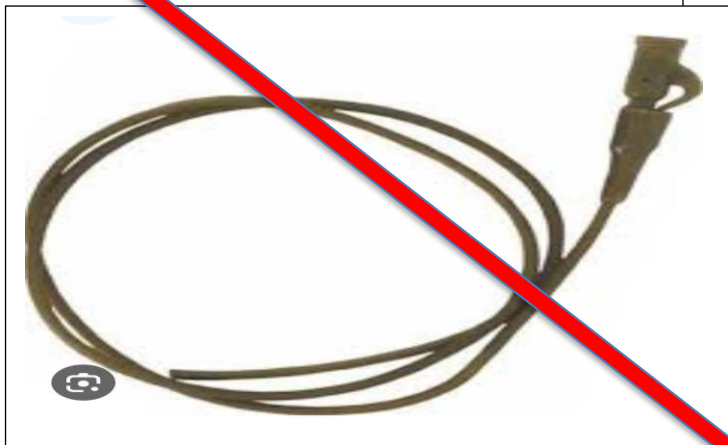
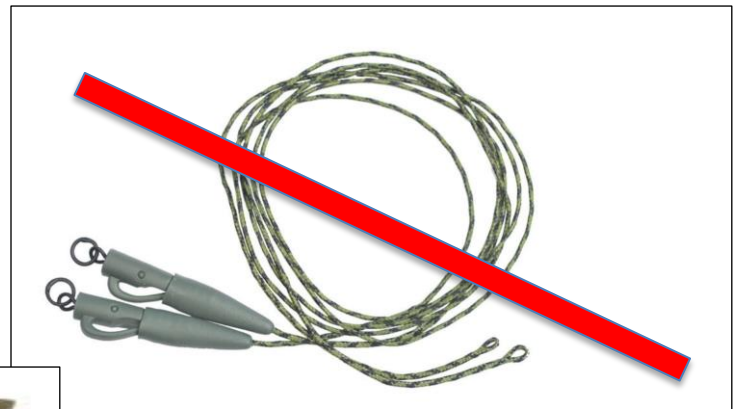
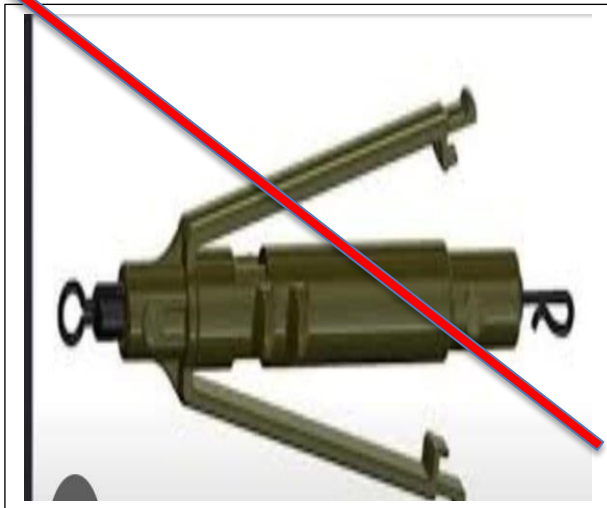
They must be kept on a leash on posts 1 and 2 due to the presence of sheep and not wander on the other posts or around the water
